## guidelines for a successful consignment experience:

1. the consignment contract period is **60** days and begins on the day your items are accepted for consignment.
2. we **ONLY** accept quality designer items in excellent condition. items will be selected based on condition, brand, and need. please ensure clothing is "**gently used**" and is free of tears, pulls, stains, fading, broken zippers, torn seams and missing buttons.
3. all items must be **CLEAN, WRINKLE FREE, and FREE of ANY PET, SMOKE, or STALE ODOR.**
4. we **CANNOT** accept clothing that is out dated. however, vintage items in good condition will be up to refinemint's discretion.
5. we accept home décor items such as lamps, pictures, statues, & small furniture pieces(must be current, and clean & free of any damage). **PLEASE NO APPLIANCES.**
6. we accept **GOOD** costume & genuine jewelry pieces. we welcome shoes & purses that are new and nearly new. **ABSOLUTELY** no knock offs will be accepted. please bring shoes in without boxes as they will be discarded. please bring in any authenticity paper regarding your goods.
7. please **LIMIT** your drop off items to **25** pieces!! this allows for variety in the shop.
8. the refinemint sales prices may be marked down at **ANYTIME** to promote the item's sale.
9. refinemint, its officers, directors, and employees are not responsible for loss of or damage to or destruction of any consigned item(s) by any cause or any reason.
10. it is the **CONSIGNOR'S RESPONSIBILITY** to track all consigned items. unsold and unclaimed items remaining in the store after the 60 contract period become sole property of refinemint boutique. Unsold and unclaimed items may be donated to benefit local charities.
11. consignors have **5** days to pick-up their unaccepted items if the drop/run procedure is used. and items left there after the **5** day period will be donated to benefit local charities.
12. refinemint maintains the right to obtain and use images of all products contained within the premises for the purpose of advertising and promotion.
13. this agreement **SUPERSEDES** any prior written or oral agreement between the parties with regards to the subject matter.

## seasonal items will be received as follows:

fall and winter	august through january
spring and summer	february through july

## pricing:

refinemint agrees to sell goods on behalf of consignor and prices shall be designated by the shop.

## payment:

it is the **consignors responsibility** to pick up payment for sold consignment goods. consignor's payment for sold goods will be available **5** business days after the sale date. consignors will receive **50%** of the sale price of each item sold within the contract period.
